- 2. Regd. Office: The Regd. Office of the Society will be are at such other place, as may, from time to time, be determine by the executive committee at Guntur only.
- 3. Area of Operation: The Area of operation and activities of the society shall extend to all over the state of Andhra Pradesh.
- 4. Aims & Objects:
- A) To Promote, develop & extend educational & cultural facilities in all the aspects and branches of education including research fecilities, sociocultural activities to all the citizens of 'India regardless of caste, cread, religion or place.
- B) To pramote, start, establish and run educational and cultural Institutions such as colleges of Arts, Sciences, Fine arts & Commerce, Public or residential schools in any place of Andhra Pradesh State for the dessemination of education in all its aspects including modern methods of education and also to pramote atheltics for students health.
- C) To pramote, establish and run Institutions of professional courses such as Engineering , Medical , Vocational etc., in any place or places in the state Andhra Pradesh and impart education to help to cater the needs of the citizens and the country.
- D) To take over and run any existing educational Institutions or Institution in any place or places of the state of A.P
- E) To promote, establish and run research institutions in any branch or branches of education including scientific and technical in any place or places of the state of A.P to help cater the incresing of needs of and to accelerate speedy scientific and technological development of the country.
- F) To Publish and circulate books, periodicals and magazines etc., which are of educational and cultural value or importance and also to provide free legal aid to the needy, to impart legal knowledge by organising legal litrecy compaigne.
- G) To get, recieve charties or aid from the state and central Govern ment and philanthropic institutions or persons.
- H) to do all such things and to perform all such acts or activities as may be necessary and proper for the pramotion and development of educational institutions and for the attainment of any or all of the above subjects and aims of the localty  $\lambda$

# THE SOCIETIES REGISTRATION ACT NO. XXI OF 1860 RULES AND REGULATIONS

## I. Interpretations :

& SAILAJA SRI GANGINENI VENKATESWARA RAD Name EDUCATIONAL SOCIETY Regd. Office: Sri SBI officers colony - 3rd line Dr.No. 4-5-29-78, Vidhya Nagar - Guntur

#### II. Membership :

#### Founder Members

A) The nine persons who subscribed their signatures to the Memorandum of Association shall constitute as Founder Members of the society. These nine Founder, Members of the socity shall be the members for time being in force in the socity with heredidatry right to nominate their If they do not nominate their eldest son or daughter successors. shall be their successor.

#### Members

Persona may be admitted to the membership subject to the unanimous approval of and on the terms and conditions determined by the executive committee of the society if it considers that their Association would be beneficial to the society.

## III. Termination of membership

Membership will cease:

- A) When any member becomes insane.
- B) When any member except the nine founder members is found to be fit and determental to the interest of the society & the Executiv committee passes a resolution terminating his membership.
- C) Any member except the nine founder members, resigns intimating in writing to the president and the executing committee a resolution accepts his resignation.
- Any one of the founder members, if he so desires, may resign giving intimation to the president relinquishing all rights of nomina tion of successor and succession of his eldest son or daughter. resignation will come into effect only on the acceptance of it executive committee by a mejority of members and from the date o acceptance of the resignation, his members and his liabilities in th societies will cease.

IV GENERAL BODY:

A) The General Body of the Society shall constitute all its members . B) The General Body may ordinarly meet atleast once in a year i.e in

the month of January.

C) A Special meeting of General Body may be convend on a notice of four days.

## V. EXECUTIVE COMMITTEE !

- A) The Executive Committee shall consist of the President/and the Vice President , The Secretary , the treasurer and 6 executive members, with a provision of co-option of member or members if necessary by the executive committee in future.
- B) All the nine founder members shall be in the executive committee for their life time.
- C) The executive committee shall meet once in every month. It may also meet as many times as it is considered by the executive committee.
- D) All matters shall be decided by a majority vote.
- E) The Secretary shall ordinarily give 7 days notice of the meeting of executive committee, and in case of urgancy he may give 24 hours notice of the meetings.

## VI. POWERS & FUNCTIONS OF THE EXECUTIVE COMMITTEE:

- A) The Executive committee shall have control over and manage administer all the educational institutions including research projects and other allied establishments specified in the memorandum of Association established and run by the society and also the institutions taken over by the Society.
- B) The executive committee shall manage and administer all the assets and liabilities of the society and of the individual institutions established by the society.
- C) The executive committee shall have the power to purchase, sell, mortgage or lease out or otherwise dispose off the properties of the society by a resolution unanimously passed by it.
- D) The executive committee shall have power to appoint personal such as teaching staff, office staff and other necessary staff members in all the institutions and establishments run by the society.
- E) The Executive committee shall be having the power to appoint or dissolve any adhoc or sub-committees and terminate the servises of teaching personnel and other staff members employed in the institutions of the society of the due enquiry.
- F) The executive committee shall have the power to do any thing or things necessaries for the good working progress of the society and all the other institutions run by society.

#### VII PRESIDENT

i) The president shall preside over the meetings of the General Body, executive committee and any adhoc or sub-committee.

ii) He shall guide the affairs of the society with the co-operation of the members of the executive committee.

iii) He will hold office for a period of 5 years and be eligible for re-election.

## VIII) THE SECRETARY :

- i) The Secretary shall be the chief executive of the society
- ii) The Secretary shall be incharge of all the properties and records of the society and all other institutions established and run by the society. He shall be incharge of the management and administration of the society in and all other instituions established by the society.
- iii) The Secretary shall have the power to appoint staff on temporary basis subject to the ratification of the executive committee later.
- iv) The Secretary shall act as correspondent having power to correspond with the State or Central Government and all other Non-Government institutions, agencies or persons.
- v) The Secretary shall perform such duties as may be allotted to him by the executing committee and shall implement all decisions of the executive committee and the General Body and be guided by the President in his duties.
- vi) The Secretary shall convence the meeting of the General Body: executive committee, adhoc or sub-committee is accordence with rule: and regulations.
- vii) He will hold office for a period of 5 years and be eligible for re-election.
- viii) The Secretary shall prepare the annual report regarding the affairs of the society and present it to the executive committee for placing it before the General Body for its consideration and approval.

## IX) THE TREASURER :

- i) The treasurer shall be incharge of and respondle for the funds of the society and all other instituions established and run by the society.
- The Treasurer shall maintain accounts up to date.
- iii) He shall recieve payments and issue reciepts on behalf of the society and all other instituions.
- iv) He shall get the accounts audited and place the audit report before the executive committee for placing the same before the General Body for its consideration and approval.
- v) He will hold office for a period of 5 years and is elegible for reelection
- X. MEMBERS OF THE EXECUTIVE COMMITTEE:
- i) The members of the executive committee shall participate in the meetings of the executive committee and give their considered opinion.
- ii) They shall carry on the duties that may be alloted to them by the executive committee.

XI. FUNDS:

- i) Funds of the society shall consist of the contributions made by the founder members and other members and donations collected from public and charitable institutions.
- ii) Funds of the society shall be kept in any of the Bank decided by the executive committee.
- iii) Funds of the society shall be spent according to the desicions of the executive committee for the attainment of the aims and objects the society.
- The Bank account shall be operated jointly by the Secretary & Treasurer.
- v) The Secretary shall have the power to spend up to Rs 2000/out prior approval of the executive committee in case of need and get the expenditure ratified by the executive with in one month.
- vi) A Reserve fund may be created from out of the reciepts and collections made for the society as decided by the executive committee.
- vii) Honorarium may be paid to any members or out sider for any service rendered by him and such honorarium may be fixed by the executive committee.
- viii) If any member has the requisite qualifications for the sprcific post he may be considered for that post and he may hold that post with out detriment to his duties as the members of the executive.
- For the working of the objects of the society or instituions founded and run by the society if any finance are required the tary with the approval of the executive body may borrow money banks or private concerns including members and repay the same the funds of the society.
- XII. QUORUM :
- i) The Guorum for any meeting of General Body shall be 1/3 rd of the total members present.
- The Quorum for any meeting of the executive committee shall be members or 2/3rd members.
- XXII. POWER TO AMEND RULES AND REGULATIONS:

The Rules and regulations of the society may be altered, replaced are by-laws made or substitute or added in a meeting of the General Body by a vote of 3/5 majority of the members present.

- THE SOCIETY MAY SUE OR MAY BE SUED IN THE NAME OF THE SECRETARY. XIV. XV. WINDING-UP
- i) In case of decisions made interms of a resolution by a 3/5 majority of the members present in a meeting after General Body to dissolve the society, the society shall be dissolved and wound up and the funds, assets and liabilities of the society shall be transfered with following sub-rule(ii)
- ii) All the funds and assets and liabilities of remaining the event of dissolution shall be transfered to such other organizion or instituior or trust having similar aims & objects of the societ
